Tournament Rules: Please keep a copy of these rules for your use.

1. Tournament will consist of three games: Regular, 9-Pin No Tap, and 3-6-9 based on the following average divisions: Division 1: Average of 190 and over

Division 2: Average of 160 to 189

Division 3: Average of 159 and under

- 2. An entrant must be an adult member in good standing with the USBC. If not a member of SCCUSBC, entrant must provide an average verification from either their local association or bowl.com.
- 3. The tournament shall be conducted on a handicap basis of 90% of 210.
- 4. Average must be 21 games or more and will be taken in this order:
 - a. 2023-24 USBC certified highest average of all USBC leagues bowled from bowl.com.
 - b. Current highest USBC certified average of 21 or more games as of May 26, 2025 (must provide a league sheet).
 - c. 2022-23 USBC certified highest average of all USBC leagues bowled from bowl.com.
 - d. If bowler has none of the above averages, bowler will bowl scratch with a 210.
- 5. This tournament will enforce USBC Rule 319c (Average Adjustments Rerating) only.
- 6. It is the bowler's responsibility to verify the accuracy of their average whether originally submitted by the bowler or others. Failure to use the correct average may result in disqualification of the bowler's scores if the submitted average is incorrect. Refer to rules 4 and 5.
- 7. A substitute bowler will be allowed for paid entries. Substitutes' averages subject to rule 4, 5 and 6.
- 8. Entry fee breakdown: Lineage \$14.25, Expenses \$1.75, Prize Fund \$24.00 for a total of \$40.00. No refunds without notification to tournament management prior to the start of the squad.
- 9. All prize monies will be returned 100%. Prize ratio will be 1 in every 6 entries per division. Prize monies will be based on total pin fall plus handicap per division. All ties will be combined, and prize money divided evenly.
- 10. Multiple participation is allowed at this tournament bowlers will cash with their highest series only. Bowlers may pre-register for more than one squad if they choose.
- 11. Tournament squads subject to cancellation due to lack of participation for this event
- 12. Check-in is 60 minutes (1 hour) before scheduled time to bowl and each bowler must check themselves in. Any bowler not checked in 15 minutes prior to the squad may lose their spot and entry fee will not be refunded.
- 13. Walk-ins and re-entries allowed based on lane availability, but must sign up no less than 30 minutes prior to the start of the squad
- 14. All prize monies will be mailed (or delivered) to the individual bowler within thirty (30) days after the close of the tournament. An exception exists when USBC has authorized delay in payment, pending settlement of any claim or protest which affects position standings.
- 15. Any rules not covered shall be governed by the 2024-25 USBC tournament rules and regulations.
